 - c) 工况数据：含计划内, 计划外工况。

- d) CEMS 维护数据：含 CEMS 故障，运维信息。
- e) 来自政府与媒体的生活垃圾焚烧企业集团与下属企业的 ESG 风险机遇。

ten Data set content:

a) Basic information: including enterprise name, address, credit code, administrative division, legal representative, commissioning date, person in charge of information disclosure, contact information, number of incinerators, design processing capacity, power generation, incinerator type, commissioning date, design processing capacity, longitude and latitude, pollutant discharge license number, brand (listed company).

b) Daily average emission data: daily average values of SO₂, NO_x, particulate matter, HCl and Co, furnace temperature data every 5 minutes.

c) Working condition data: including planned and unplanned working conditions.

d) CEMS maintenance data: including CEMS fault, operation and maintenance information.

e) ESG risks and opportunities of municipal solid waste incineration enterprise groups and subordinate enterprises from government and media.

eleven Recommended use of data set (for example only, not limited to the following uses)

a) Primary market: pre acquisition due diligence of individual waste incineration power generation enterprises.

b) Secondary market: when investing in the stocks or bonds of the listed companies of waste incineration power generation, the valuation is made from the dimensions of flue gas control ability and operation ability involved in the data set.
